B. PROGRAMME :

1. Issue of Nomination Paper on **9th September, 2026** from 9 A.M to 4 P.M. and **10th September, 2026** from 9-00 A. M. to 2-00 P.M.
2. Submission of Nomination Papers on **10th September, 2026** from 10-00 A.M. to 3-00 P.M. and **11th September 2026** from 10 A.M. to 2 P.M.(With Triplicate of Nomination Fee Payment Receipt).
3. Scrutiny of Nomination Papers on **11th September, 2026** from 3-00 P.M. onward.
4. Display the list of valid candidates on **11th September, 2026** after completion of Scrutiny.
5. Withdrawal of Nomination Papers, if any, on **13th September, 2026** from 10-00 A.M. to **12-00 noon**.
6. Display of the list of contesting candidates on **13th September, 2026** at 1.00 P.M.
7. Class campaign/Stage campaign on **15th and 16th September, 2026** from 10.00 A.M. to **02.00P.M.**
8. Election will be held, if required, on **18th September, 2026** from 9-00 A.M. to 12-00 Noon.
9. Counting of votes will be held on **18th September, 2026** from 1-30 P.M. onward and result of election will be declared on the same day after completion of counting process.
10. The Oath-taking Ceremony of the elected office bearers will be held on **22nd September, 2026** at **11-00 A.M. in Room No. 27.**

C. ELIGIBILITY OF CANDIDATES AND VOTERS:

1. All regular students of Lanka Mahavidyalaya for the session **2026-27** shall have the right to vote in the election
2. Each voter shall have to come in full prescribed college uniform along with his / her identity card at the time of casting of vote.

3. A student shall become eligible as candidate / proposer of a candidate/ seconder of a proposal if his / her college dues are cleared for the entire session, 2026-27 provided that he / she has 75% class attendance in each subject.
4. A student who stood as candidate against any post for the Election to Students' Union Lanka Mahavidyalaya, Lanka till the session 2025-26 shall not be eligible as candidate against any post. However, a student who has contested an election as a class representative at the higher secondary (H.S.) level shall remain eligible to contest elections after admission to the undergraduate program at Lanka Mahavidyalaya.
5. One student shall be able to stand for one post only.
6. Students of TDC-IIIrd Year (5th Semester) class only will be able to stand for the post of President & Vice President.
7. The **General Secretary** shall not be a student of H.S standard and FYUGP-3rd Year (5th Semester).
8. For the post **Boys' Common Room Secretary** the candidate, proposer and seconder must be male student and for the post of **Girls Common Room Secretary**, the candidate, proposer and seconder must be a female student.
9. For the post of Class Representative of a certain class the candidate, proposer and seconder must belong to that class.
